Bidders are required to follow the electronic bid submission procedure as specified in e-GP system operating guideline 2073 and user manual issued by PPMO which are available in e-GP system.
5. Pre-bid meeting shall be held at Devghat Rural Municipality, Devghat, Tanahun at **2025, Jan-05**.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 on 2025 Jan-15** at the office of Devghat Rural Municipality, Devghat, Tanahun. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRS **1,05,000.00**, which shall be valid for 30 days beyond the validity period of the bid.


