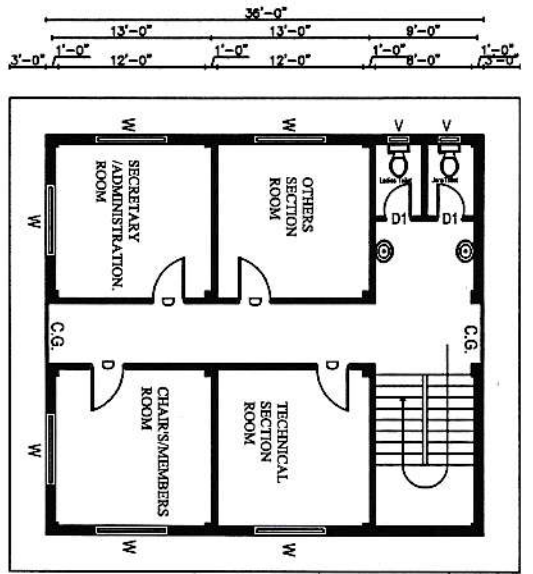

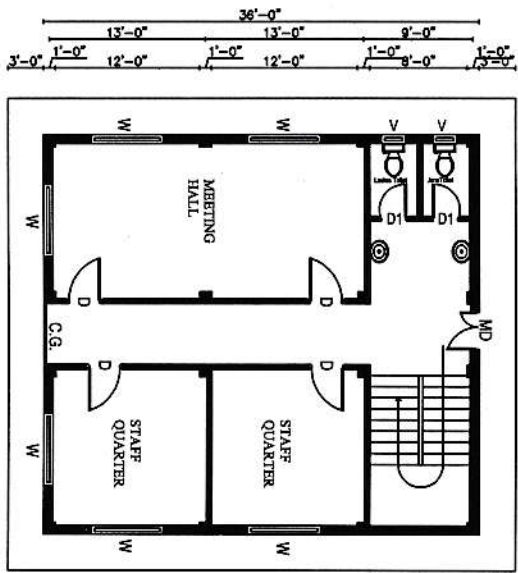


GROUND FLOOR PLAN
